NOTICE OF 2022 THIRD EXTRAORDINARY GENERAL MEETING

NOTICE IS HEREBY GIVEN that the 2022 third extraordinary general meeting (the “**EGM**”) of Datang International Power Generation Co., Ltd. (the “**Company**”) will be held at 1616 Conference Room, Datang International Power Generation Co., Ltd., No. 9 Guangningbo Street, Xicheng District, Beijing, the People’s Republic of China (the “**PRC**”) at 9:30 a.m. on 25 November 2022 (Friday) to consider and, if thought fit, pass the following resolutions:

ORDINARY RESOLUTIONS

1. To consider and approve the Resolution on the Entering Into of the Financial Services Agreement with China Datang Finance Co., Ltd. *(Note 1)*
2. To consider and approve the Resolution on the Provision of Guarantee to Pingtan Company *(Note 2)*

SPECIAL RESOLUTION

3. To consider and approve the Resolution on Adjustment to the Financing Proposal of Datang International as the Parent Company for the Year of 2022 *(Note 3)*

CLOSURE OF THE REGISTER OF MEMBERS OF THE COMPANY

Holders of H-shares of the Company (the “**H Shareholders**”) should note that, pursuant to the Articles of Association of the Company (the “**Articles of Association**”), the register of members of the Company will be closed from 21 November 2022 (Monday) to 25 November 2022 (Friday) (both dates inclusive), during which period no transfer of any H-shares of the Company will be registered. H Shareholders whose names appear on the register of members of the Company on 21 November 2022 (Monday) are entitled to attend and vote at the EGM. In order to be entitled to the attendance of the EGM, H Shareholders are required to deliver the transfer document together with the relevant

share certificates to the H-share registrar of the Company, Computershare Hong Kong Investor Services Limited, at Shops 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong at or before 4:30 p.m. on 18 November 2022 (Friday).

Notes:

1. On 30 August 2022, the Company entered into the financial services agreement with China Datang Finance Co., Ltd. The transactions contemplated under the financial services agreement constitute continuing connected transactions of the Company. China Datang Corporation Ltd. and its associates will abstain from voting for relevant resolution.

For details, please refer to relevant announcement of the Company dated 30 August 2022 and the circular dated 28 October 2022 of the Company.

2. As considered and approved at the fifth meeting of the eleventh session of the Board, it was approved that Fujian Datang International Renewable Power Company Limited or Datang International would provide financing guarantee to Fujian Pingtan Datang Offshore Wind Power Co., Ltd., with the total amount of guarantee to be provided in the next 12 months not exceeding RMB1,525 million, and the proportion of guarantee to be provided to the total loans not exceeding 80% of shareholding ratio.
3. As considered and approved at the fifth meeting of the eleventh session of the Board, the adjustment plan on the financing proposal of the Company as the parent company for the year of 2022 was approved, which additionally increased a financing amount of RMB20 billion on basis of the financing proposal for the year of 2022.
4. Other Matters
 - (1) Each of the H Shareholders entitled to attend and vote at the EGM, is entitled to appoint one or more proxies to attend and vote on his/her behalf. A proxy need not be a shareholder of the Company.
 - (2) If the H Shareholders have appointed more than one proxy to attend the EGM, the proxies can only exercise their voting rights by way of poll.
 - (3) To be valid, the H Shareholders must deliver the proxy form, and if such proxy form is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarized copy of that power of attorney or other authority, to the Company's H-share registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong, in not less than 24 hours before the time scheduled for holding the EGM.

- (4) The EGM (onsite meeting) is expected to last for one hour. Shareholders and their proxies attending the EGM shall be responsible for their own travel and accommodation expenses. In view of the current situation, shareholders who wish to attend the EGM are recommended to give priority to exercising the shareholders' voting rights by appointing the Chairman of the meeting to vote.
